# INTRODUCTION

Located in Chandrapur, Maharashtra, in Central India, Tadoba-Andhari Tiger Reserve is one of India's prominent reserves. Its tropical dry deciduous forest ecosystem harbours 90+ tigers, and there are over 200+ tigers in the larger landscape, one of the fast-growing tiger population in India. Tadoba became one of India's earliest national parks when it was notified in 1955. In 1986, 506.32 sq. km. of forest adjoining the park was notified as Andhari Wildlife Sanctuary. The national park and wildlife sanctuary were merged in 1995 when Tadoba-Andhari Tiger Reserve (TATR), spanning 625 sq. km. was established. TATR has functional connectivity with other Protected Areas and tiger reserves of Central Indian landscape, holding more than a quarter of the world's wild tiger population. It is a source population of tigers in this landscape, which is critical for long-term survival of tigers in India.

Tadoba supports several carnivore species, including leopard and dhole, with sambar, chital, wild pig and gaur being common prey species. Sustained efforts over decades have led to revival of tigers and wildlife in TATR. These include creating undisturbed areas through incentivised relocation, grassland development to improve prey base, improving water availability, intensive tiger monitoring and enforcing sustained protection measures to safeguard wildlife from threats.



## OBJECTIVES OF TATRCF

To protect and conserve the tiger and tiger habitat with peoples participation.

To reduce the dependence of local communities on forests, mitigate human-wildlife conflicts, and create alternative livelihood opportunities.

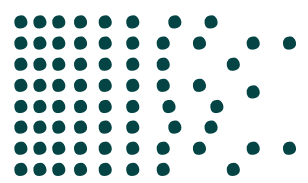
Primary Response Teams (PRTs) are a group of self-motivated youths of the buffer areas of Tadoba-Andhari Tiger Reserve, which are working dedicatedly to reducing and mitigating man-animal conflicts in villages. TATR has 42 dedicated PRTs with around 200 community members, who are alert 24/7 to work towards mitigating the Human-Wildlife Conflict (HWC), and protecting and conserving iconic species like tiger, leopard, and other wildlife, and securing the lives of local communities. PRT members are an invaluable link between the community and the forest department. HWC mitigation strategies are more effectively planned and implemented with their inputs. PRTs have also been formed in 100 villages across the Chandrapur district.

### ROLES AND RESPONSIBILITIES OF PRTs

- Regularly monitoring and patrolling around forest areas of villages to document direct and indirect evidence of movement of the tiger, leopard, sloth bear, and submit its findings and accordingly inform the local villagers, forest department, and people representatives to take precautionary measures.
- Regularly conducting awareness activities in villages and schools on mitigating HWC issues, and other meetings.
- Installation of camera traps in adjoining forest areas and understanding the movement of big carnivores.
- Handling mobs when tigers, leopards, and sloth bears enter villages and protecting lives of villagers and wild faunas.
- Participating in other activities like wildlife research, wildlife and other surveys, overall awareness, etc.

# 2 Corporate Social Responsibility Activities

## RAPID RESPONSE TEAM

TATR has a dedicated Rapid Response Team (RRT) to execute wildlife rescue operations in TATR and adjoining forests. Established in 2018 with a dedicated team of experienced wildlife veterinarians, RRT has four specially trained STPF personnel and a police constable.

RRT plays the most important role in controlling and mitigating the man-animal conflicts in the periphery villages of TATR, adjoining forest areas of FDCM, and territorial forest divisions.

Till date, the RRT Units have rescued 58 conflict tigers, 46 leopards, and 30 sloth bears in and around the villages of Chandrapur district.

## 3.1 NATURE EDUCATION ACTIVITIES FOR SCHOOL STUDENTS IN BUFFER AREAS

Nature education is an important pillar in protecting and conserving nature and natural resources with community participation. TATR conducts regular nature education activities for students of Chandrapur district under program **“Chala Mazya Tadobala”** which means “Come to My Tadoba”. Every year more than 5,000 students visit TATR to understand the importance of forests and wildlife. At awareness camps, students of buffers are taught about the role of forests in human life, mitigation of conflicts, respecting wildlife, etc.



## 3.2 NATURE AWARENESS AND EDUCATION PROGRAM FOR LOCAL COMMUNITIES

TATR regularly conducts nature education programs for local women, youth and shepherds to sensitize them on roles and responsibilities of community in mitigating conflicts, importance of forests for local development and of alternative livelihood programs initiated by TATR.

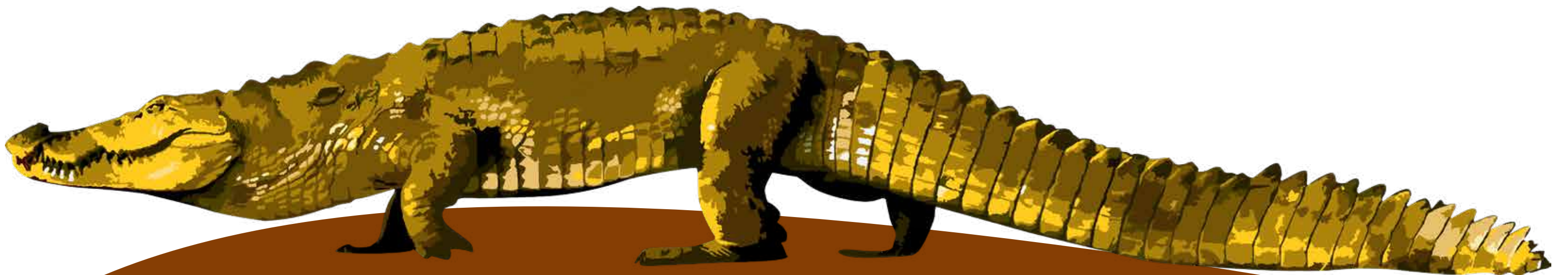

## COMMUNITY INITIATIVES

### 4.1 WELFARE OF REHABILITATED VILLAGES OF TATR

TATR was notified in 1995 and as per the legal mandates of Project Tiger, it was impossible to carry out developmental work for communities dwelling inside. They lacked access to facilities like livelihood opportunities, education, healthcare services, sanitation etc. which kept them deprived of development and prosperity. Considering their hardships and need for undisturbed spaces for tiger as flagship species, Central Government initiated a program to rehabilitate villages from the reserves and connect them to better facilities, leading to development. There were 6 villages in Core area of TATR, viz. Botezari, Kosla, Navegaon (Ramdegi), Jaamni, Palasgaon (Singru), Rantalodhi. These villages were systematically rehabilitated to new locations near TATR maintaining the cultural and social integrity of the communities. The process underwent with the consent of villagers and major rural development initiatives were carried out at the new site. The majority of the living amenities are in the place and are funded through TATR and the government, yet there are several issues that have arisen that are difficult to fulfil from administration due to budgetary constraints. It would be of immense benefit to conservation if your support can appraise issues of such villages.

### 4.3 MITIGATION OF MAN – ANIMAL CONFLICTS

Human-Wildlife Conflict (HWC) refers to a negative interaction between humans and wildlife, which can have adverse effects on human socio-economic and cultural aspects, as well as on the conservation of wild animals and their habitats. Man-animal conflicts are serious issues within the TATR landscape, impacting both human communities and wildlife.

The conflict arises due to the expanding human population in the region, resulting in increased land and resource demands. This has, in turn, led to the destruction, degradation, and fragmentation of natural habitats, forcing wild animals to encroach more frequently into human-inhabited areas. Additionally, the higher presence of cattle in and around forested areas has contributed to greater livestock predation. The intensified grazing pressure further diminishes the availability of natural forage for wild herbivores.

As a consequence, these conflicts foster hostility towards wildlife and the forest department among local communities. This animosity can have severe and lasting implications for conservation efforts. In fact, it has already reached chronic levels in the Chandrapur district and is poised to become one of the most significant challenges facing the Greater Tadoba Landscape in the future.

#### HOW YOU CAN HELP...

Currently, TATR provides direct employment to over 1,000 young members of the community, indirectly benefiting approximately 5,000 family members. Moreover, TATR has extended its offerings beyond tiger tourism, encompassing activities such as kayaking, boating, cycling, educational camps, adventure programs, nature trails, and more.

Frontline forest staff serve as the backbone of Tadoba-Andhari Tiger Reserve, dedicating their efforts to safeguarding and conserving wildlife and natural resources for the nation's sustainable future. These forest personnel reside round the clock at the anti-poaching camps within the Tiger Reserve, often with limited basic amenities. To bolster their capacity and improve their well-being, we aim to provide enhanced facilities and protective equipment in the form of donations or instruments.

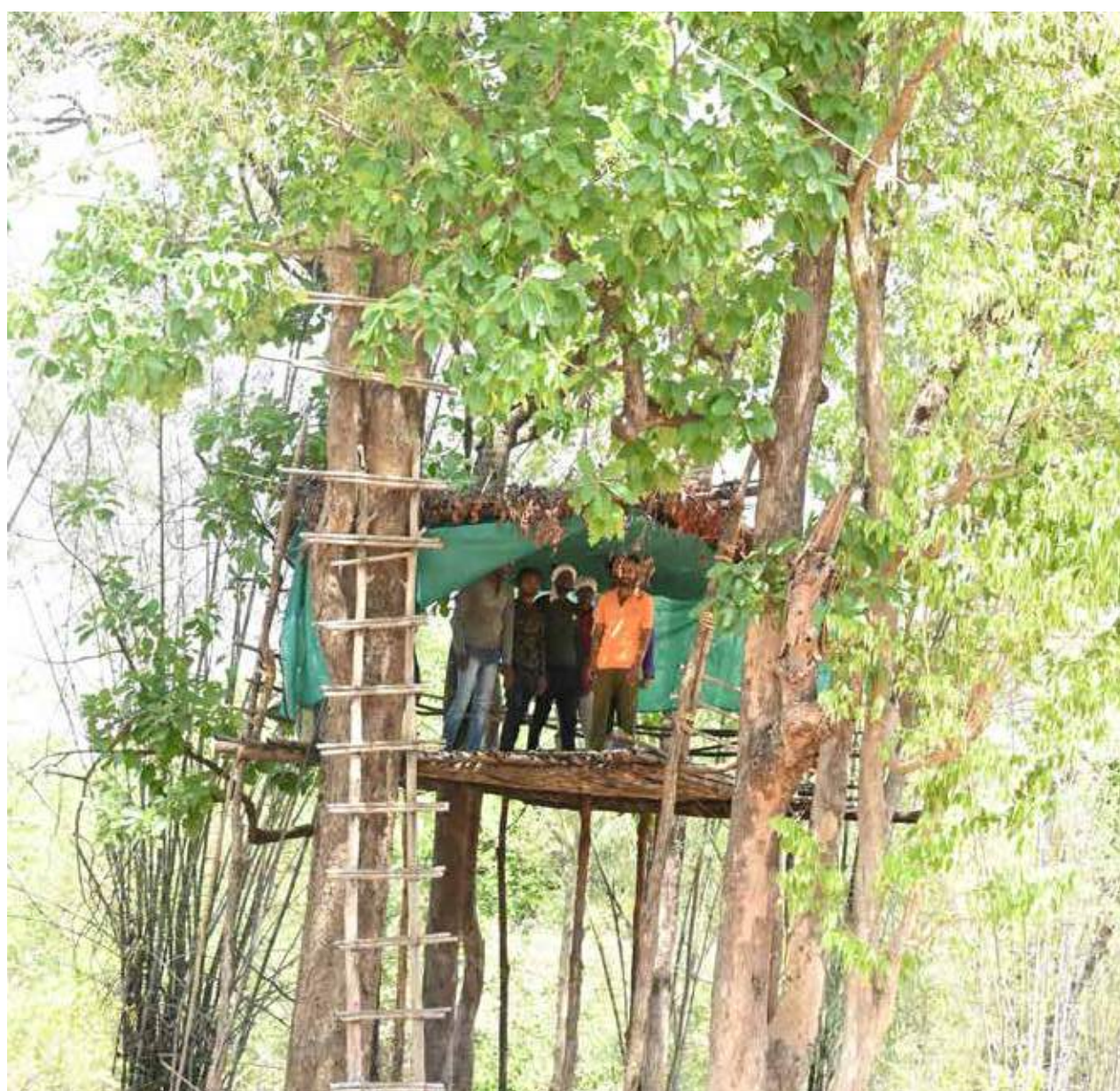


### 5.3 FOREST FIRE CELL

Forest fires pose the most significant threat to wildlife and the ecosystem. To address this critical issue, TATR has established a dedicated Forest Fire Cell, comprising over 300 committed forest fire watchers who reside in protection huts. Their unwavering efforts are aimed at effectively controlling fires and safeguarding both wildlife and natural resources.

## ECO-RESTORATION, HABITAT DEVELOPMENT AND PROTECTION

To achieve a healthy habitat for wildlife and promote the well-being of the ecosystem, we aim to encourage the growth of indigenous, palatable grass species in the grasslands while removing invasive species that negatively impact the ecosystem. Our goal is to provide a safe, secure, and happy environment for herbivorous animals to raise families, ultimately contributing to the growth of tiger population for a better future. To support this, we have regenerated and established artificial waterholes equipped with solar units to ensure a continuous 24/7 water supply for wild animals. This helps reduce incidents of man-animal conflicts, as herbivores find both shelter and food within grassland, eliminating the need for them to migrate outside the forest. To safeguard wildlife and natural resources, we have developed anti-poaching camps and protection facilities within the Tiger Reserve.

### HOW YOU CAN HELP...

Your donation can contribute to the removal of weed species, the regeneration of perennial waterholes, effective grassland management, and the repair and construction of essential anti-poaching camps, along with providing necessary equipment for these camps.





# SOLID WASTE MANAGEMENT

TATR is committed to achieving a plastic-free Tadoba through active community involvement. TATR has taken up an initiative to establish and operate a solid waste management unit in Moharli village. This unit collects and segregates garbage from nearby villages, resorts, and local shops into dry and wet waste categories. The wet waste is processed into compost, which is then utilized in local agricultural lands, while the dry waste is sent for recycling in Chandrapur. This milestone program plays a crucial role in maintaining a clean environment and safeguarding the wildlife in the region.

**TATR is the only Tiger Reserve in Maharashtra working in Solid Waste Management.**

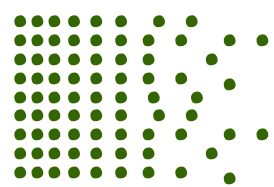
